During 2014, Little Bit continued to learn, develop and grow during our first full year at Dunmire Stables. The year also provided exciting challenges and significant changes.

In July, Little Bit entered into a period of transition while the Board of Directors sought a new Executive Director. Deputy Director Cluny McCaffrey was named the Interim Executive Director and with the full support of the Board, kept the therapy and volunteer programs, facility and administration running smoothly. Michael Dunmire was a smart, kind and generous man who was passionate about bettering the lives of others. He was an integral part of the Little Bit community for over 30 years; inspiring everyone with his genuine love and support of the Little Bit mission and the care he showed the riders and patients.

Starting in 1978 as a board member, his vision and commitment were instrumental in the successful completion of the first capital campaign, "A Stable Future," which supported the Little Bit remodeled and expanded facility in Woodinville. His Board service included terms as Treasurer and President and he ultimately served on the Advisory

Board. Along with his wife, Phyllis, he served as Honorary Chair of the recent "Extraordinary Strides, Transforming Lives Campaign", which successfully raised \$10.4 million. He and Phyllis provided the leadership gift that made it possible for Little Bit to buy the current 17-acre site and transform our ability to deliver the Little Bit mission. Although he never asked to have the property named after them, we were honored to do so, and Dunmire Stables was born.

It wasn't always serious business with Mike, however, he could also be found flipping burgers at the Ben Barrato Memorial BBQ or wearing his top hat to the auction with a big smile. The Reins of Life Auction was always the Dunmire's favorite event. They sat together at the Reining Table every year, surrounded by friends, inspiring the Little Bit community to give generously. He leaves behind an incredible legacy of kindness, integrity and philanthropic leadership. He will be missed by all he touched.

Siena has faced many challenges, including communication. When Siena started equine-assisted therapy she struggled to lift her arm up to point at an object.

Since Siena started therapy at Little Bit, Mary Ellen has noticed many positive changes in her daughter. Siena has increased the core strength she needs in order to have the physical control to communicate. Siena is now able to pick up various objects, such as a bucket or riding crop, which is something she hadn't been able to do in the past. Holding things and carrying them with a purpose is a new world for Siena and a great help for mom. More importantly, Siena loves to ride her horse Ross at Little Bit, and nothing makes her smile like trotting!

Mary Ellen says, "**I am thankful for each tiny step, each small stride, each gentle gallop. They all remind me that Siena's future can be filled with meaningful relationships, a therapeutic community, and more communication. Little Bit—what an extraordinary place where taking the reins and mastering movement in the arena translates to taking the reins and navigating life more fully.**"




